As a waste producer you need to be aware that many “everyday” waste items must not be deposited in your general waste containers. Legislation now classes all of the following as **Hazardous Waste:**



Aerosols

Most Batteries

Toners

Adhesives Acid Descalers

Oil Filters Caustic Soda

Photochemicals

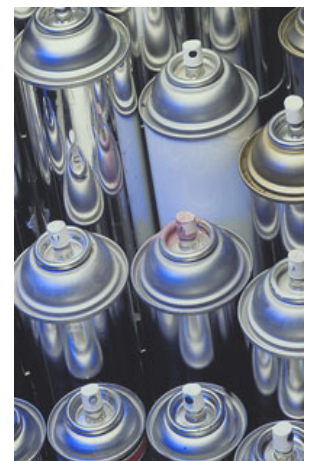
Oil Tins Resins

Solvents Paints

Thinners Cleaning Chemicals

Contaminated Rags, Wipes and Absorbents

(Any combination of the above may be placed in the Haz-Box)



The **Haz-Box** service ensures legislative compliance which is straightforward and cost effective.

We will supply you with 55 litre lidded plastic boxes for the storage of your mixed hazardous waste. Upon a pre-determined collection schedule, your Haz-Box will be emptied and the waste segregated on-site, within our collection vehicle. Many of these items can then be recycled.

Certain larger waste items, such as computer equipment and fluorescent tubes, can be collected at the same time.
