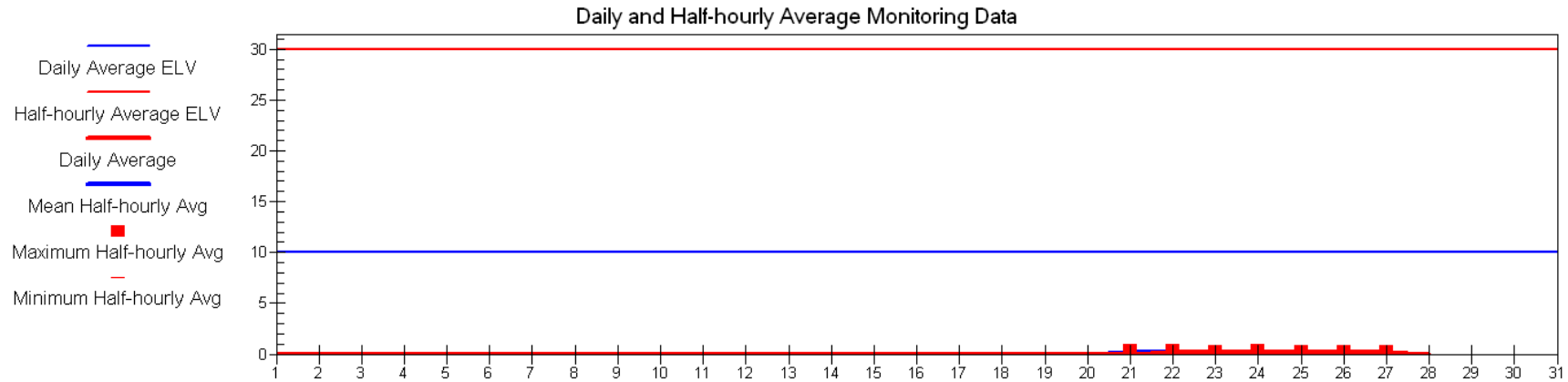

**Reporting of Continuously Monitored Emissions to Air for Dust mg/m3 at Emission Point A1 For the month of February 2010**



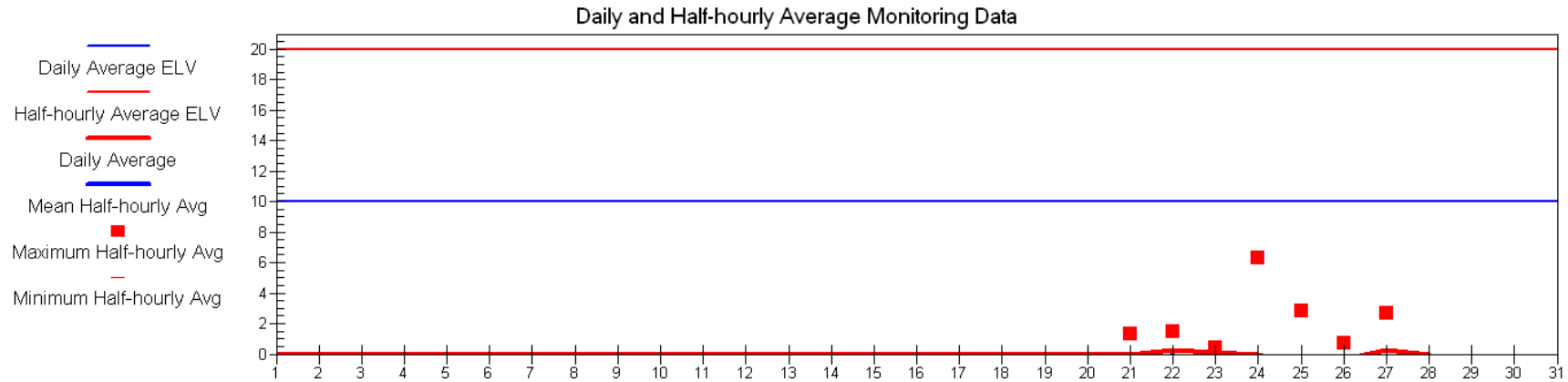
